## A SAMPLE OF RESEARCH PUBLICATIONS FROM VARIOUS FIELDS OF INTEREST IN APPLIED BEHAVIOR ANALYSIS

Applied behavior analysis (ABA) is the study and application of scientific principles and procedures to effect socially important behavior change. ABA is often narrowly defined as an approach to treat autism spectrum disorders. In fact, the profession of behavior analysis has made countless improvements in the lives of individuals in many places and conditions including education and learning, behavioral challenges, occupational safety, organizational behavior management and performance, substance abuse, brain injury, Alzheimer's, ADHD, behavioral medicine and Down Syndrome.

Behavior analysts publish in a variety of peer reviewed journals in education, medicine, organizational behavior management, developmental disabilities and so on. The preeminent journal for many behavior analysts is the Journal of Applied Behavior Analysis (JABA). JABA has been in continuous publication since 1968. A review of JABA demonstrates some of the areas studied by behavior analysts:
